What is the UK Self Sponsorship Visa?

Technically, there is no such visa as the “UK self-sponsorship visa” – or at least, not by this title. References to a self-sponsorship visa in the UK that you may have encountered elsewhere are in relation to a process whereby an overseas national may be able to come to the UK to work for their own business, without the need to have a separate UK sponsor other than the company itself.

If you are successful in being approved to come to the UK under the self-sponsorship visa route, you might subsequently use it as a platform to secure permanent residency and British citizenship for you and your family.

This method for moving to the UK as an entrepreneur isn't very often talked about. However, it has attracted greater mention in recent times as a consequence of alternative entrepreneurial visa routes to the UK having closed down or become restricted.

Requirements for a Self Sponsorship Visa

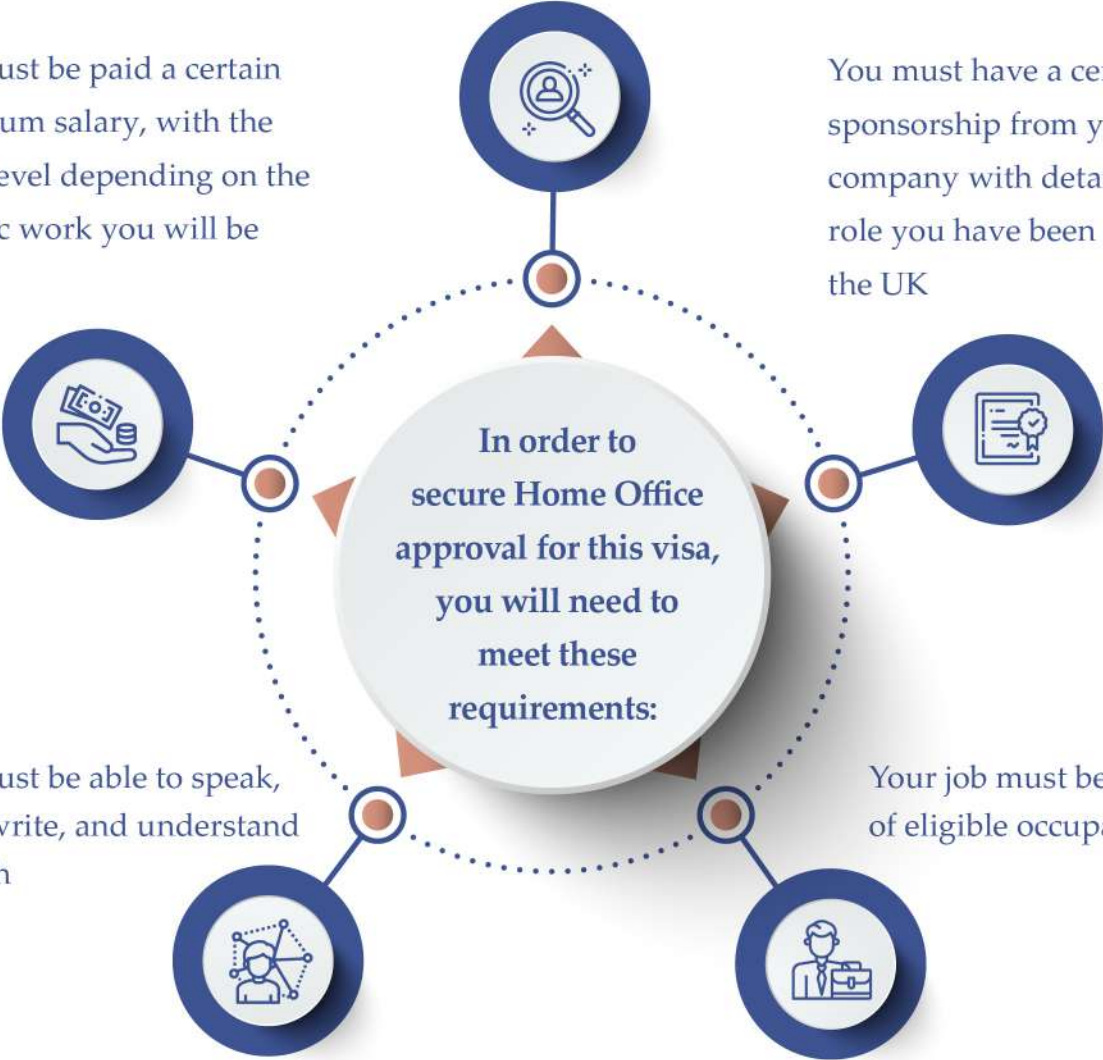
The prospective UK employer being approved by the Home Office

You must be paid a certain minimum salary, with the exact level depending on the specific work you will be doing

You must have a certificate of sponsorship from your UK company with details about the role you have been offered in the UK

You must be able to speak, read, write, and understand English

Your job must be on the list of eligible occupations

Key Documents Required For Your Application

Most organisations wishing to apply for a sponsor licence in the UK will be expected to supply at least four documents in support of their application. The exact documents that will need to be provided will depend on the status and circumstances of your organisation

Once your UK company has been approved for a sponsor licence by the Home Office, further documents will be required for your application for the Skilled Worker visa. These will include:



Your certificate of sponsorship reference number.



Proof of your English language knowledge.



A valid passport or other document showing your identity and nationality.



Your job title and annual salary.



The occupation code for your job.



Your UK company's name and sponsor licence number.

There are other documents beyond the above that you might be required to provide for your UK self-sponsorship visa application.

What is a Certificate of Sponsorship (CoS) ?

The CoS is an e-document generated by the Home Office which is issued to the Company. The document is given to the employee which allows them to apply for their Visa and onboards them to the Company.

The Company must assign a CoS to each non-UK national the Employer is looking to Sponsor for work purposes.

When a Licence is granted, the Home Office may issue the Employer with 1 CoS. If the Employer wishes to hire more than 1 non-UK National worker, the Employer can request an increase of their CoS allocation through the Sponsor Management System (SMS).

Management of Your Sponsor Licence

Managing the Sponsor Licence can be a complex maze to navigate through and our Immigration team are suitably placed to help manage your Licence. We will work collaboratively with you to ensure that you obtain the Licence and then keeping it.

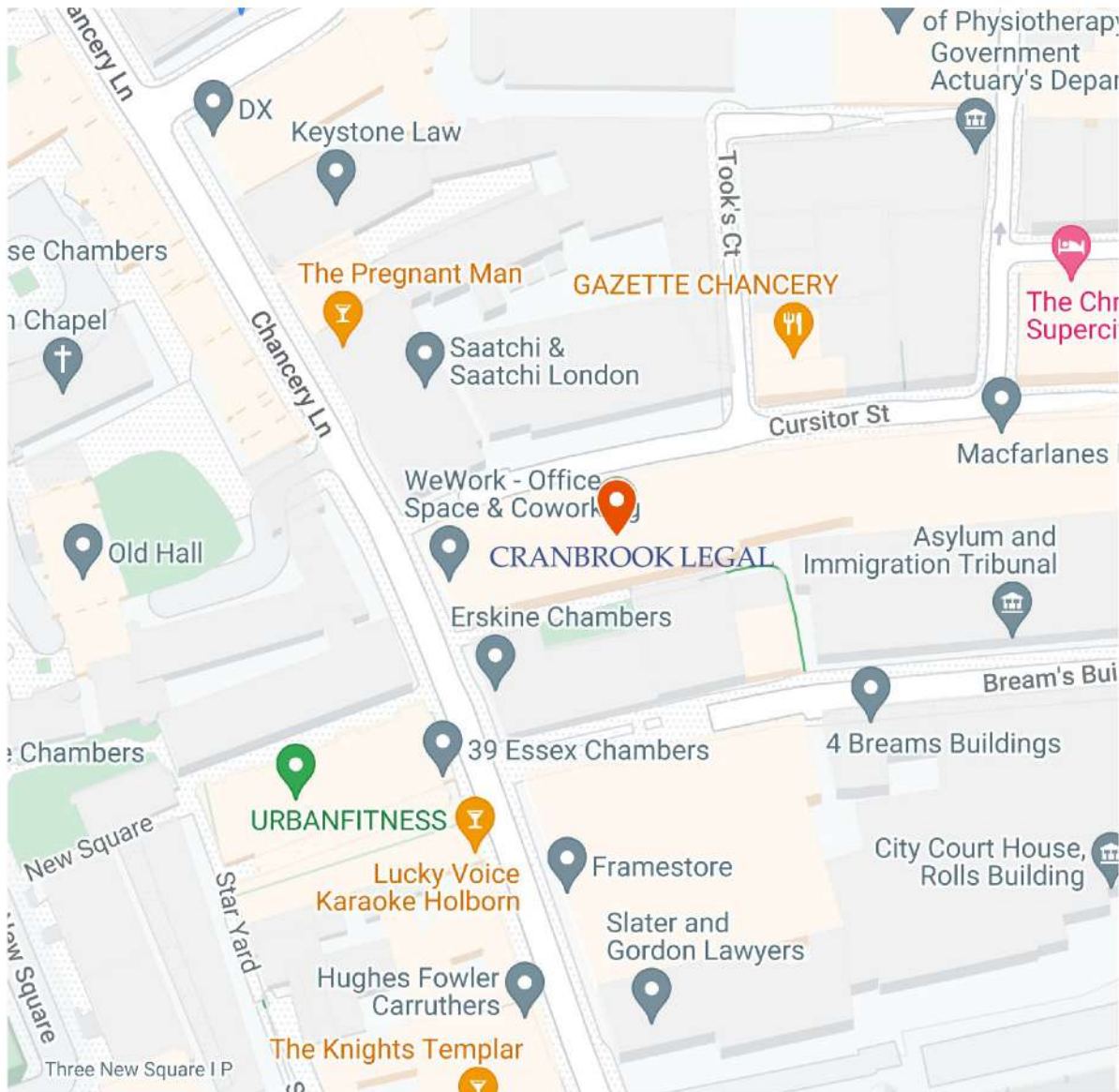
